Rescind motion to award bid for demolition of 308 Maple to ARD Farms – A motion was made by Jones, seconded by Richison to rescind the motion to award the bid for demolition of 308 Maple to ARD Farms. Vote: Gammon, abstain; Richison, yes; Cornell, yes; Black, no; Jones, yes.

Trustee Gammon made a motion to open and award the bids for demolition of 308 Maple and 305 Benton together. Clerk White suggested correcting the award of 308 Maple first then make a motion for 305 Benton. Trustee Black stated businesses make motions to handle multiple actions. A motion was made by Gammon, seconded by Jones to open and award both bids for demolition of 308 Maple and 305 Benton together. Trustee Gammon stated the bid for 305 Benton can be awarded but not to proceed yet. Vote: Cornell, yes; Black, yes; Jones, yes; Gammon, yes; Richison, yes.

ITEP Grant/Resolution – The ITEP grant was discussed at the regular board meeting held on September 16, 2024. The resolution in support of an ITEP grant application for bicycle and pedestrian improvements on various routes in Rossville was included in the board packets but was not voted on. The resolution was presented this evening committing to the grant and paying up to 20% local match to complete the design, construction, and construction engineering and up to 50% required local match for right-of-way acquisition and street lighting and all ineligible costs associated with the project for sidewalks. The total of the costs for the project is \$608,389, of which 20% is \$121,677.80. The sidewalks from Route 1 to the yellow apartments (200 Stufflebeam Drive) can be reduced based on the score. Motion was made by Gammon, seconded by Black to approve the resolution and committing up to 20% if the grant is received. The funds will be taken out of the TIF Fund. Vote: Jones, yes; Black, yes; Cornell, yes; Richison, yes; Gammon, yes. Resolution 2024-07 passed. The grant has to be turned in prior to September 30, 2024.

Motion was made by Jones, seconded by Gammon to adjourn the meeting. Vote: Jones, yes; Black, no; Gammon, yes; Cornell, yes; Richison, yes. The meeting adjourned at 5:20 p.m.
